RECYCLING RULES

Operating the Recycling Center costs the Township a significant amount of tax dollars. Following the rules will help keep everyone's property taxes lower. People who refuse to follow the rules will not be allowed to use the facilities. The most important thing to remember is that garbage must be kept separate from recyclables.

RECYCLABLES:

RECYCLABLES MUST BE CLEAN. THAT MEANS NO SOIL OR FOOD RESIDUE.

Most recyclables are single streamed in one dumpster, so they may be collected at home in one container, except noted below.

*Cardboard must be clean and dry. No oiled or wax coated. Flatten the boxes.

Magazines may be mixed with the cardboard.

*All glass must be clean! Jars and bottles only. Other glass materials, such as light bulbs, dishes, and window glass should go in the landfill dumpster.

*Plastic: Can be mixed with other recyclables. Rinse and flatten as much as possible. NO lids, rings, Styrofoam, plastic bags, or containers that held oil, antifreeze, or pesticides

*Cans: Keep aluminum separate from other metals.

*Metal: All metallic materials go into a separate dumpster, including clean food cans. No other things, such as plastic, glass

or wood can go in that dumpster. We accept all kinds of appliances, BUT you must have the Freon pumped out of items such as refrigerators, air conditioners, and dehumidifiers or pay the Town a \$25.00 fee to do so.

*Florescent Bulbs: Keep separate and
DO NOT BREAK THEM.

*Electronic Items and Batteries are stored separately.

*Keep Drained Oil Filters separated.

THINGS WE CAN NOT ACCEPT:

* Anything that you can legally burn. The Township provides burn barrels. If you do not like to burn, you can compost those materials instead.

*Tires, liquid paint, farm or household chemicals, animal carcasses.

*Materials from construction or remodeling such as, but not limited to: plaster, dry wall, roofing refuse, insulation (you need to get a dumpster of your own for those kinds of projects) (Clean drywall accepted).

VOTER I.D. CHANGES:

Photo Identification required. You cannot cast a ballot until you have met ID requirements. Your photo ID does not need to show a current address.

ACCEPTABLE FORMS OF VOTER ID:

*Wisconsin driver's license

*WI DOT-issued photo ID card

*U.S. Passport

*Military card

(The above documents may not have expired earlier than the date of the last November election)

*Certificate of naturalization issued w/in last 2 years
*Unexpired WI driver's license or state ID receipt
*ID card issued by a federally recognized Indian tribe
*Unexpired ID issued by a WI accredited university or college-must contain issue date, student signature, and expiration date w/in 2 years of issue, along with proof of current enrollment.

FREE Wisconsin ID available through the DMV

VOTER REGISTRATION CHANGES:

You may not register to vote the Saturday, Sunday, or Monday before an election. You must reside at your address for 10 days to be eligible to vote. A corroborating witness may no longer be used for proof of residence. Without acceptable proof of residence (utility bill, bank statement, Wisconsin I.D., paycheck, government document, or lease in your name at your current address) you cannot vote.

Registration on Election day:

Documentation listed above needed.

ABSENTEE VOTING:

Absentee ballots are kept sealed and secure until delivery to the polls on Election Day. You may vote in person absentee with the Town Clerk the two weeks before an election until the Friday before the election. To receive an absentee ballot by mail, submit a written request containing: Your name, address where registered to vote, where ballot should be sent, your original signature, and a photocopy of your WI photo ID or passport.

*Return your ballot early enough that it reaches the Clerk by Election Day.

*Sign the Certificate Envelope.

*Have a witness sign the envelope.

*Please read your absentee ballot instruction letter very carefully. We want your vote to count!
